

- Between January and April 2023, GFA under management of the Company increased by 6.22 million sq.m., including 5.19 million sq.m., or 83.44%, from third parties;


> Contracted GFA

- Between January and April 2023, contracted GFA of the Company increased by 7.25 million sq.m., including 5.81 million sq.m., or 80.13%, from third parties;
- As in April 2023, the Company had contracted GFA 280.28 million sq.m., including 182.77 million sq.m., or 65.2%, from third parties.
